S.C. Code of Laws §39-57-30 requires that the seller of a business opportunity must file a copy of the disclosure statement required by S.C. Code of Laws §39-57-30 before placing an advertisement or making other representations to prospective purchasers in the State.. In order to comply with the law, the seller of every “business opportunity” is subject to the following requirements:
