Metropolitan Courts are to be established at such places in every metropolitan area having population of ten lakh or more. It has jurisdiction throughout such metropolitan area. The presiding officers of such courts shall be appointed by the High Court.

Only the Judicial Magistrate of First Class may be designated as Additional Chief Judicial Magistrate. Metropolitan Magistrate-They are established in Metropolitan areas. The Metropolitan Magistrate shall work under the instructions of the Sessions Judge.
